HOUSE DEMOCRATS SELECT REP. BROWN TO BE NEW RANKING MEMBER OF HOUSE VETERANS AFFAIRS COMMITTEE

On November 19, 2014, House Democrats selected Rep. Corrine Brown as the new Ranking Member of the House Veterans Affairs Committee (HVAC). The current HVAC Ranking Member, Rep. Michael Michaud (D-ME) will be leaving Congress in January 2015. In the race to succeed Rep. Michaud the contenders were Rep. Corrine Brown (D-FL) and Rep. Tim Walz (D-MN). Rep. Brown had the advantage of seniority with her being the second highest ranking member of the HVAC while Rep. Walz, a junior member of the HVAC, ran on his experience of being a retired Command Sergeant Major who served 24 years in the Army National Guard. Rep. Walz will maintain his seat on the House Veterans Affairs Committee in the 114th Congress. We at AUSN look forward to working with both Rep. Brown and Rep. Walz in addressing veterans issues in the 114th Congress.

HOUSE VETERANS AFFAIRS COMMITTEE HEARING ON INFORMATION SECURITY ISSUES

The House Committee on Veterans Affairs held an oversight hearing on VA's outdated information technology security weaknesses and its plans to address how they will move ahead in the future. The Committee heard testimony from the Government Accountability Office (GAO) and VA's Office of Inspector General (VAOIG) regarding the investigations they have on going with VA's security vulnerabilities and VA's work to address GAO and VAOIG recommendations moving forward. The VA informed the committee that it has dedicated \$60 million to implement numerous processes and programs to ensure it is able to protect veterans' information and address

information security weaknesses. Mr. Stephen Warren, VA's Chief Information Officer, assured the Committee that no causal relationship exists between alleged appointment manipulation and VA's IT issues. HOUSE VETERANS AFFAIRS COMMITTEE HEARING ON VETERANS EDUCATION PROGRAMS

On Wednesday, House Veterans Affairs Subcommittee on Economic Opportunity discussed legislative proposals that would improve the processes through which State Approving Agencies (SAAs) inspect and approve programs for GI Bill participation. Ryan Gallucci, VFW National Service Director, explained how SAAs should have statutory authority to improve new non-college degree programs at not-for-profit schools in the wake of such programs popping up at GI Bill eligible schools and operating under "deemed approved" status. SENATE VETERANS AFFAIRS COMMITTEE HEARING ON VETERANS MENTAL HEALTH AND SUCIDE

The Senate Committee on Veterans Affairs held an oversight hearing on mental health and suicide among veterans. The Committee heard from the mothers of two veterans who committed suicide and learned about alternative mental health care programs. VA testified that it has expanded mental health care programs, including joint DoD/VA programs to provide "warm handoffs" between DoD and VA mental health care services for transitioning service members. VA also informed the Committee that a growing number of veterans are taking advantage of mental health services offered through the Veterans Crisis Line and readjustment counseling services through its 300 Vet Centers. HOUSE ARMED SERVICES COMMITTEE HEARING ON RELIGIOUS ACCOMMODATIONS

On November 19 2014, the House Armed Services Committee (HASC) Subcommittee on Military Personnel held a hearing on religious accommodations for military service members. Subcommittee Chairman Rep. Joe Wilson and Ranking Member Rep. Susan Davis led the hearing. Hearing witnesses included Michael Berry, Senior Counsel, Director of Military Affairs, Liberty Institute; Dr. Ron Crews, Chaplain (COL.) USAR Retired, Executive Director, Chaplain Alliance for Religious Liberty; Rabbi Bruce E. Kahn, D.D., CAPT, CHC, USN (Ret.); Travis Weber, Director, Center for Religious Liberty, Family Research Council; and Michael L. Weinstein, President, Military Religious Freedom Foundation.

The hearing had to be delayed halfway due to votes and the Chairman allowed the Democratic members of the subcommittee not to return due a Democratic Caucus meeting that overlapped with the second half of the hearing.
